Avoiding Scams To Lower Your Credit Card Interest Rate

Some scammy debt relief companies will say just about anything to get your money. They promise to get you a lower credit card interest rate, claiming to be able to save you thousands of dollars but they don't have special connections to do that. Anything a debt relief company says they can do for you, you can do for yourself — for free.

You've probably gotten calls or messages from companies guaranteeing — for a fee — to get you a lower credit card interest rate and promising to save you thousands of dollars. These scammy debt relief companies will tell you just about anything to get your money:

- Scammers say they have special relationships with banks and credit unions. They don't.
- Scammers may claim that the lower interest rates they're promising are only available for a limited time. They say you need to act now. But they're just trying to rush you into a quick decision.
- Scammers guarantee you'll get your money back if they can't get your rate lowered. It's not true. Instead, you're likely to end up paying extra balance transfer and other fees (that they didn't tell you about), as well as the fee paid to the company.

Anything these companies say they can do for you, you can do for yourself — for free. You have just as much clout with your bank or credit union as these companies.

Also, by law, companies that sell debt relief services on the phone can't charge a fee before they settle or lower your debt.

How to Protect Yourself:


- Don't share your credit card, bank account or SSN with anyone who calls you out of the blue.
- Don't pay a company any money before they help you.
- Hang up on robocalls.

Carr Valley Cheese

During the month of June, we were able to visit with several different dairy companies to show our commitment and appreciation to them during June Dairy Month. We had a chance to sit down with Master Cheesemaker, Sid Cook of Carr Valley Cheese, to talk cheese and dairy, and sample some awesome Carr Valley staples as well as some of Sid's favorite cheeses.

Carr Valley has been operating for over 100 years. With two master cheesemakers and twelve cheesemakers they are not short on cheese expertise. With five different production and manufacturing plants, they produce roughly 20,000 pounds of cheese a day! Carr Valley has over 100 different types and flavors of cheese and offer cows milk, goat milk, sheep milk, and mixed milk cheeses. One of their most famous, original and

award winning cheeses is Bread Cheese! Which is oven baked until it has a brown, crusty top. This melty, squeaky cheese is just perfection. If you're looking for a new cheese to try, Sid shared what he considers their most underrated cheese, Grand Canaria. This is an aged, mixed milk cheese that is cured with olive oil. It brings together a fruity, nutty, sweet, intense and pungent flavor all in one cheese!

We asked Sid what he enjoys most about the dairy industry. he shared, "It has never felt like a job. I have always had a passion for cheese and to be in an industry that is so collaborative within itself and the ability to partner with outside vendors and companies who appreciate and understand the dairy industry make doing what I love so rewarding."
